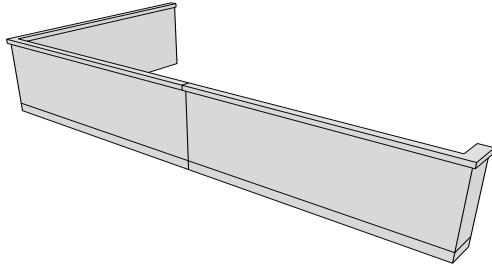


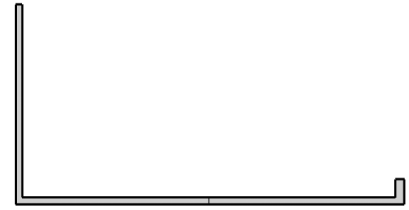
Jury Box Enclosure

Jury box enclosure in 3 sections, with solid wood cap and horizontal reveal.

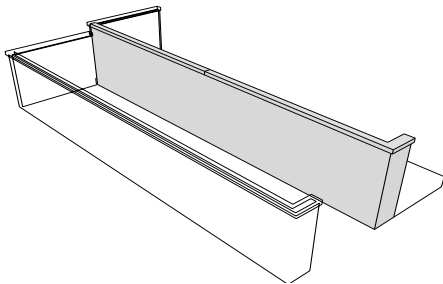

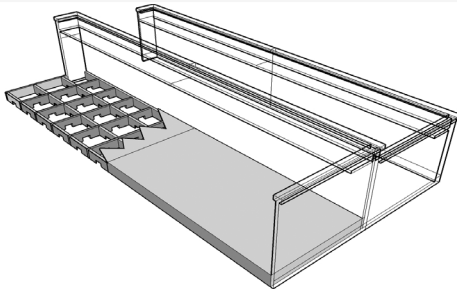
